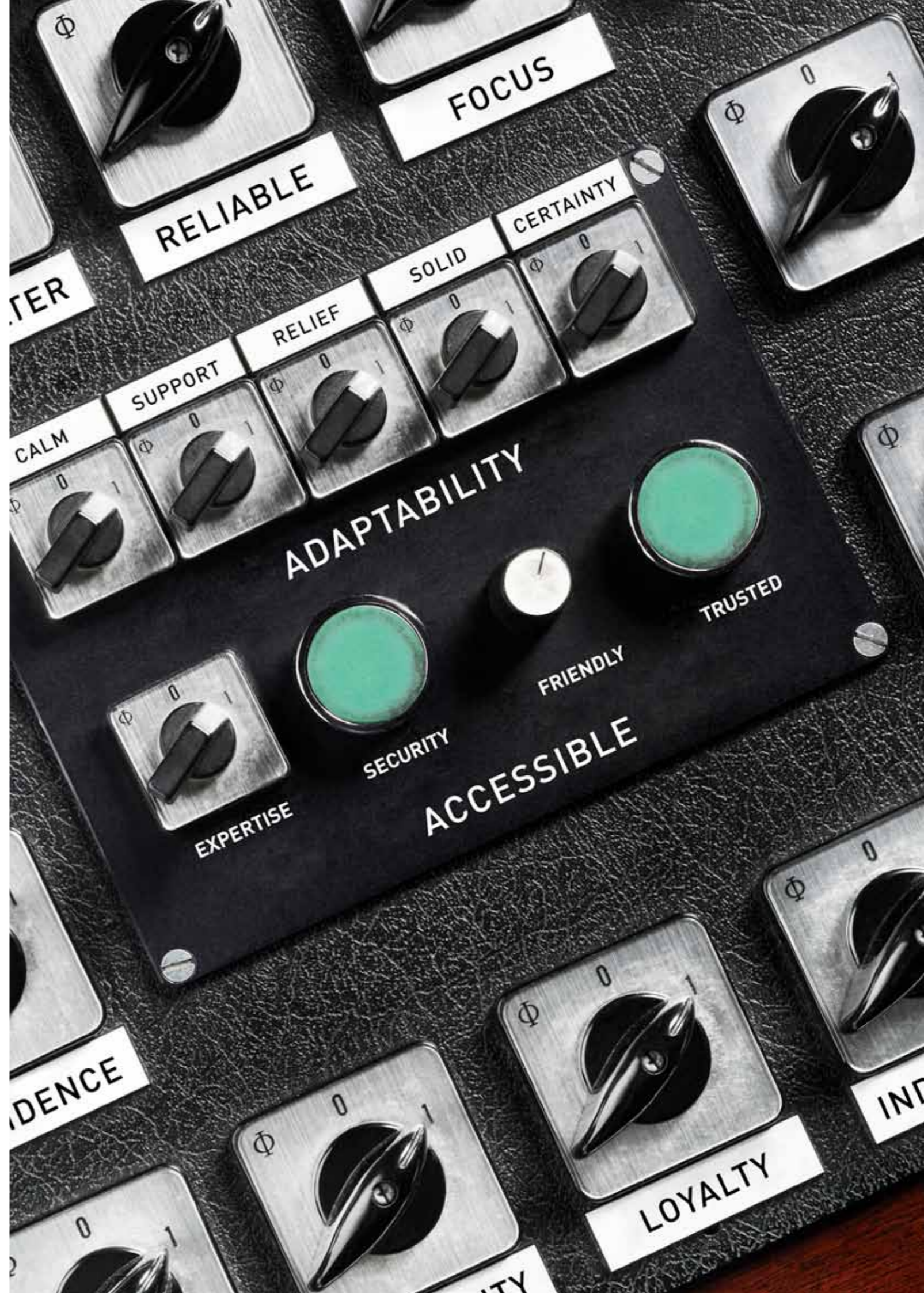

HOW WE HELP

We have designed P&I and hull covers for owners and operators of small craft, such as passenger vessels and local ferries, fishing vessels, tugs, working boats, coastal cargo carriers, barges and other small craft. These should be no larger than 3000 GT and be trading in European domestic or inland waters.

Terms and conditions

Knowing what your costs are is important for the operators and owners of small craft, which is why we offer fixed premiums for both hull and P&I. For vessels up to 1000 GT and/or carrying up to 100 passengers, we can offer limits of USD 20 or 50 million for P&I and up to USD 5 million for hull

insurance. If your needs are greater than this, we offer the more extensive P&I insurance covers with higher limits on a mutual basis. This means that you become a Member of our P&I Club – a club that provides collective self-insurance to its Members by pooling their risks to obtain ‘at cost’ insurance. The club is controlled by its Members and does not exist to make a profit.

If you would like extended protection, we offer a number of additional covers, including war, machinery, ice, defence, loss of hire, and other extended related cover products.
